## FINDING AND JUDGMENT

Comes now the plaintiff, State of Indiana, by John J. Dillon, Attorney General, and Thomas Kern, Deputy Attorney General, and come now the defendants, Charles Frederick Zimmerman and Cora Ethel Zimmerman (H&W) and Mabel H. Zimmerman, by their attorney of record herein, Robert Duffy, and plaintiff and said defendants now withdraw their request for a jury trial, and this cause is now submitted to the Court upon the issues formed by the exceptions heretofore filed by the plaintiff and said defendants.

And the court being duly advised finds as follows:

- 1. That the plaintiff, State of Indiana, filed its complaint for the appropriation of an easement for highway right of way over defendants' real estate on the 19th day of February, 1965, and the defendants were properly served with notice as provided by statute prior to the hearing in this cause.
- 2. That on the 15th day of March, 1965, being the day set for the hearing of the cause, an order was entered upon the record of the Superior Court of Vigo County, signed by Harold J. Bitzegaio, Judge, showing that an easement for highway right of way over the defendants'

real estate was condemned for the uses and purposes described in said complaint.

- 3. That by said order the court also appointed three disinterested freeholders of Vigo County to assess the damages and benefits to the defendants caused by the appropriation.
- 4. That on the 26th day of March, 1965, said court-appointed appraisers returned their report to the court showing total damages in the sum of Nineteen Thousand Four Hundred Thirteen Dollars (\$19, 413.00), and the Court ordered the appraisers' fees set at Seventy Five Dollars (\$75.00) each.
- 5. That the plaintiff, State of Indiana, paid the award of the appraisers together with the fees for the services of said appraisers to the clerk of the court on the 23rd day of April, 1965, and the defendants, Charles Frederick Zimmerman and Cora Ethel and Malely Jimmerman (Haw), Asubsequently withdrew said award on the 28th day of August, 1965.
- 6. That the plaintiff, State of Indiana, filed exceptions to the urt-appointed appraisers' report on the 31st day of March, 1965.
- 7. at the defendant, Charles Frederick Zimmerman, filed exceptions to the ourt-appointed appraisers' report on the 30th day of March, 1965.
- 8. That the defendent Terre Haute Savings Bank filed a disclaimer of any interest in the proceeds made available to the defendants by the plaintiff herein.
- 9. That the total value of the easement for highway right of way taken and damages to the remaining land of the defendants is Eighteen Thousand Dollars (\$18,000.00), and that the defendants, Charles Frederick Zimmerman and Cora Ethel Zimmerman (HAW) and Mable H. Zimmerman, should recover from the plaintiff, State of Indiana, total damages in the sum of Eighteen Thousand Dollars (\$18,000.00).

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that the order of appropriation herein on the 15th day of March, 1965, be and the same is hereby confirmed and the easement for highway right of way over defendants' real estate described in plaintiff's complaint be, and the same is appropriated, said easement for highway right of way being more particularly described as follows:





IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that the defendants, Charles Frederick Zimmerman and Cora Ethel Zimmerman and Mabel H. Zimmerman, have and recover from the State of Indiana as final and total damages the sum of Eighteen Thousand Dollars (\$18,000.00), which said amount has already been paid the defendants Charles Frederick Zimmerman, and Cora Ethel Zimmerman, herein when they withdrew the court-appointed appraisers award of Nineteen Thousand Four Hundred Thirteen Dollars (\$19,413.00), so nothing more is owing the defendants in this cause.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that the Terre Haute Savings Bank having filed its disclaimer in this cause shall take nothing by this judgment.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that the defendants Charles Frederick Zimmerman and Cora Ethel Zimmerman and Makel H. Zimmerman (H&W), Ashall refund to the Clerk of the Court the sum of One Thousand Four Hundred Thirteen Dollars (\$1,413.00), and the Clerk of the Court shall pay said partial refund of the Court-appointed appraisers' award to the plaintiff, State of Indiana.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that the Clerk of this Court should be, and he hereby is, directed to execute and deliver his Clerk's Deed to the plaintiff, State of Indiana, dated as of the date of this judgment, conveying to the plaintiff, State of Indiana an easement over the real estate appropriated by the plaintiff in this cause, such conveyance to be subject to all non-delinquent taxes and assessments.
